Participation charter



Opening

ACCORD CIRCES is an aid to the realization and the setting in motion of new initiatives which are born in the vision of a fairer, more responsible humanity, with more solidarity and which expresses itself by the respect for oneself, the others, nature as well as tolerance, sharing and exchange. It supports the actions that aim to redirect the world towards awareness and that place Man and Nature in the center of people's concern, in perfect harmony. It thus reconnects all the fields of thought and action for a practical realization of reproducible initiatives wherever useful.

Participation

It is open to everyone, without any limitation, and to all countries, CIRCES being present in more than twenty countries. A form is available on the https://circes.org site and it is to be returned, completed, before the scheduled date for each session. The participation can be individual or collective and it can concern a group, an existing association, a school or another structure. Its languages are French, English, Portuguese and Spanish.

Jury

The jury does not include a fixed number of assessors but it will be composed of members of CIRCES and, in particular, of its board of directors as well as the presidents and / or the members of the associations who participate in the actions of CIRCES and / or those who are helped by this one and that, without any limit of members number. All decisions shall be made by the majority vote of those present. The jury meets on a specific date for the examination of the received files and will select one or more laureates who will be invited to an oral defense meeting at the CIRCES headquarters (22, rue Beaunier-75014 PARIS).

In case of impossibility or unavailability, related in particular to the distance, a video conference may be set up. The presentation will include an oral defense and an exchange with the members of the jury. If the intervention must be in a language other than French, it will be necessary to provide for the presence of a translator.

Decision

The jury deliberates at the end of the defense and it has complete freedom in its choices. It may retain one or more contribution and distribute the funds available to it as it thinks fit. The decision is sent to the participants, at the latest **ONE MONTH** after the defense, by any means. During this period of instruction, the supporter may be asked for additional information.

Delivery of the ACCORD CIRCES

ACCORD CIRCES is presented during a meeting which will take place at the headquarters of the association CIRCES (22 rue Beaunier-75014 PARIS) and the date of which will be fixed for each session.

Follow-up of initiatives and actions

CIRCES will monitor the initiatives and actions that have been rewarded within the financial limit granted, without excluding an additional financial contribution over time. It will assist in the implementation of the project, either through its expertise or that of various people or other associations, or by setting up a relay in the country or countries of establishment or implementation. It can participate in development, communication, etc. These actions are determined according to the needs of the laureate (s) and the financial, material or other capacity of CIRCES and the limit that it has set and which may result in total funding or part of the project, or a simple material, non-financial assistance.

The amount of financial assistance is fixed for each session by decision of the CIRCES Board of Directors. It is divided among the laureates according to the choices made by the jury.

Reproducibility and rights

ACCORD CIRCES is part of a «free rights» initiative that must win the support of the laureate(s). It corresponds to the ethics of CIRCES, namely that its use goes beyond legal property and that freedom and sharing animate the actions. ACCORD CIRCES is a commitment to reorient the world and to change people's consciousness. It must benefit the greatest number. It operates outside any commercial purpose.

The collected information is necessary for your membership. It is subject to computer processing and is intended for the secretarial staff of the association. In application of articles 39 and following of the law of January 6th, 1978 modified, you have a right to accessing and rectification on any personal information.
